Dear Comptroller General Dodaro:

We write to request that the U.S. Government Accountability Office (GAO) assess the scope of the problem of oppressive child labor, the capacity of government agencies to monitor, research, and conduct enforcement of our child labor laws, and the effectiveness of current efforts to address the employment of illegal child labor.

Congress intended to eliminate oppressive child labor in the *Fair Labor Standards Act of 1938* (FLSA). Nevertheless, 85 years after passage of that landmark law, child labor in the U.S. is on the rise. High-profile exposés of companies illegally employing and overworking children in dangerous jobs<sup>1</sup> put a face on the numbers available in the Wage and Hour Division's (WHD)

own data, which show a near quadrupling of the number of children involved in child labor violations since 2015—and these are just the cases that have been detected.<sup>2</sup>

This surge in child labor violations is happening while decades of budget constraints have left key agencies with less capacity to address the problem. The U.S. Department of Labor’s (DOL) Wage and Hour Division (WHD) has expended steadily decreasing effort on enforcement in the last five years.<sup>3</sup> Moreover, the Department of Health and Human Services’ National Institute for Occupational Safety and Health (NIOSH), which conducted a robust body of research on children’s occupational illness and injury in the 1990s, has cut back that work significantly, leaving policymakers with an “absence of timely, valid, and reliable injury data.”<sup>4</sup>

Given the breadth and complexity of these issues, we ask that GAO undertake an investigation into the illegal use of child labor in the United States and, specifically, answer the following questions:

- What has been learned about the extent of child labor in the U.S. and related illness and injury among child workers since GAO reported on these matters in 2018,<sup>5</sup> and what information gaps remain?
- What strategic changes has DOL made in its enforcement practices to address child labor violations, and what is known about the effectiveness of specific enforcement tools, including the hot goods provision, and challenges, if any, in applying them?
- To what extent is DOL coordinating with other agencies to prevent and detect child labor violations, including through the new Interagency Child Labor Task Force?
- To what extent are NIOSH and DOL conducting research and statistic programs that track child labor and child workers’ occupational illness and injury and inform DOL’s strategic enforcement practices?


